PREFACE

Problem of legal regulation of relations in the field of health care is becoming extremely important at the following stage of Ukrainian society development. Its relevance is significantly increasing in the context of medical reform, namely the transformation of primary care, optimization of the network of medical institutions, the introduction of electronic health care and reform of the emergency medical care system.

This problem is especially acute at the current stage of transformation of the health care system, which will relate to the legal regulation of secondary and tertiary care providers, autonomy of all health care facilities, the formation of hospital districts and the introduction of a state-guaranteed package of medical services. All of these issues require detailed legal regulation.

Nearly 80 thousand students from 158 countries are studying now in Ukraine. The vast majority of them are students of medical universities and faculties. Given the above, it is important to train a modern specialist who has professional knowledge of medical law and legislation. These factors necessitate the development of appropriate educational and methodological support.

To facilitate the assimilation of the course topics, it is proposed to study the content of medical law with the help of schemes that reveal the elements and logic of the structure of this discipline.

The publication addresses the issues of the basics of public administration in the field of health care (topic 1), public health management (topic 2), medical law and its place in the system of law and legislation (topic 3), the legal basis of health insurance and medical care (theme 4), the human rights system in the field of health care (theme 5), the legal status of the subjects of medical relations (theme 6), defects in the provision of medical care (theme 7) and legal liability in the field of health care (topic 8).

The author in no way claims to be exhaustive coverage of the course topics, much less the completeness and correctness of the judgments contained here. However, we believe that our views and approaches will be useful to students and teachers of medical, dental, legal specialties who study medical law.

A separate part of the textbook contains a dictionary of Ukrainian legal terminology in medical law. It includes legal terms and terms that are most common in medical law curriculum at Ukrainian universities. The need for such a publication is due to the difficulty of translating professional legal vocabulary into English. As the author's teaching experience shows, this is most difficult for those students who do not have sufficient legal terminology.

Proposed dictionary should not be considered as a legal book of reference. Interpretation of the vocabulary included to the dictionary is subordinated to the educational and methodical tasks of the course "Medical Law". That is why it cannot be considered as a reference, complete and comprehensive publication. It should also be noted that the translation of certain legal terms is complicated by the impossibility of their direct transfer to the English legal context (primarily due to the lack of appropriate analogues).

These features of the dictionary are explained primarily by its educational objectives and goals. The main purpose of this section is to provide students with the necessary basic ideas about the features of legal vocabulary, to introduce the reader to the general legal context of Ukrainian law and to facilitate further acquaintance with the original legal texts in Ukrainian. Given the above, the dictionary can have an independent meaning and be used to study not only the basic medical and legal terms, but also legal vocabulary in general.

The dictionary contains more than 1,600 terms and phrases and has about 4,000 words. This is the first publication of this type in Ukraine, given that the author realizes that he failed to evenly cover the terms used in each of the topics of the General Part of Medical Law. Obviously, , more complete and comprehensive dictionaries which will take into account the shortcomings of previous editions of medical law will appear in Ukraine later.

We hope that the proposed publication will be useful not only for foreign students of medical institutions and medical faculties of Ukrainian universities, but also for students and teachers of foreign universities who study the legal systems of Eastern Europe.


